Suppose that the Carbolic Smokeball affair took place this virus season, not that of 1891-92, and was addressed to the covid pandemic, not influenza. Suppose the following additional differences in the facts: The bank deposit was not said to show "sincerity", but "good faith" in the matter. The bottom of the ad said in fine print: "Terms and conditions apply. Visit: covidsmokeball.co.uk." That website included a page entitled "Offer Terms and Conditions" containing a lengthy list of typical standard form clauses. Clause 10 was a condition that the claimant "register" via the website, and include proof of purchase, to accept the offer. Clause 77 said that the offer is non-transferable. Clause 38 said "\*\*\*DISCLAIMER: THE COMPANY MAKES NO REPRESENTATION THAT THE SMOKEBALL CONFERS IMMUNITY AGAINST COVID, AND SHALL NOT BE LIABLE FOR ANY LOSS OR DAMAGE IN CONNECTION WITH THIS PROMOTION, HOWSOEVER CAUSED.\*\*\*" Mrs. Carlill, 93, is a resident of BC. The company shipped her a ball, ordered in her name and paid for by her grandson Sheridan, a medical doctor in England. Mrs. Carlill used the ball as directed. A day after concluding the prescribed course of use, she heard about the ad and reward from her neighbour Nigel, and registered, without providing proof of purchase. Although asymptomatic at the time she registered, two days later she was diagnosed with covid. After a lengthy hospital stay, Mrs. Carlill recovered. She now wants to sue the Smokeball Company for the advertised reward plus \$75,000 CAD in necessary healthcare expenses in her recovery. Assess Mrs. Carlill's legal situation and advise her on the prospects of her intended claims. (60 MARKS)
